SUBJECT: 2021 Redistricting Process

RECOMMENDED ACTION

Receive report from the Office of the County Executive relating to the 2021 Redistricting Process.

REASONS FOR RECOMMENDATION

The Special Meeting of the 2021 Advisory Redistricting Commission (Commission) is the first convening to begin a public process, which will culminate in new supervisorial district boundaries based on the 2020 census data. The process is codified in Resolution BOS-2021-50, which is attached to this report and outlines that the process will be public and requires significant public outreach to engage the community. The Office of the County Executive has established a redistricting website (www.sccgov.org/2021redistricting) to provide information and resources on the redistricting process to the community.

Since this is an open and transparent process, any members of the public or the Board of Supervisors, who wish to communicate with the Commission, can email 2021redistricting@ceo.sccgov.org. If the email pertains to official business of the Commission, the email will be posted on the redistricting website (www.sccgov.org/2021redistricting) and noticed on the next Advisory Redistricting Commission meeting agenda.

The Commission and the Redistricting Process will be supported by the County's Redistricting Team, comprised of members from many County departments included, but not limited to, the Office of Clerk of the Board, Office of the County Counsel, and the Registrar of Voters. The Commission will also receive technical assistance from Redistricting Partners, the County's expert consultants, to guide us through the process. At the second virtual Commission meeting on Wednesday, July 21, 2021 from 6:30 pm to 8:30, the Commission will also review a workplan with information on topics and training to be covered at each meeting.

BACKGROUND

At the April 6, 2021 (Item. No 22) Board of Supervisors meeting, the framework was established for the 2021 Redistricting Process. The framework aims to maintain flexibility to maximize opportunities for community engagement during a compressed timeline because of the significant delay in the release of the 2020 census data. This framework also included establishing a fifteen-member 2021 Advisory Redistricting Commission, with 3 commissioners from each supervisorial district.

The Board of Supervisors adopted Resolution BOS-2021-50 establishing the 2021 Advisory Redistricting Commission on April 20, 2021 (Item No. 59). The resolution directed Administration to establish an advisory redistricting commission composed of 15 members to hold public hearings, collect community input, and recommend to the Board updated supervisorial district boundaries. The resolution sets forth the criteria for membership on the Commission as well as the selection and appointment process for the members.

RESOLUTION NO. BOS-2021-5D

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA ESTABLISHING THE 2021 ADVISORY REDISTRICTING COMMISSION

WHEREAS, pursuant to federal, state, and local law, supervisorial district boundaries for the County of Santa Clara must be redrawn after receiving data from the U.S. Census Bureau from the decennial census that is distributed by the State of California to all local jurisdictions;

WHEREAS, the U.S. Census Bureau is scheduled to complete processing 2020 Census data by September 30, 2021. This date is six months later than the original anticipated date of completion and significantly reduces the timeframe in which district map updates must occur in order to meet the current statutory deadline of the Board of Supervisors ("Board") to adopt the final map establishing updated supervisorial district boundaries, after holding at least two public hearings itself, by December 15, 2021;

WHEREAS, the State of California will release the redistricting data needed for local redistricting approximately thirty (30) days after the U.S. Census Bureau's completion in order for the State to implement state law requirements for incarcerated persons to be counted at their last known residence address, if possible, for redistricting purposes pursuant to Elections Code section 21003;

WHEREAS, significant changes in federal and state laws have revised the redistricting process. At the state level, those changes are codified in Elections Code sections 21000 through 21509, which add new requirements for the redistricting process including extensive public outreach requirements, additional public hearing requirements, and a prioritization of redistricting criteria that changes the map drawing process compared to prior redistricting processes;

WHEREAS, the redistricting process is subject to the Voting Rights Act of 1965, as amended; and,

WHEREAS, an advisory redistricting commission will allow the Board to adopt a framework for a redistricting process and begin robust community outreach and input, while also maintaining a streamlined process that can be responsive to any potential timeline fluctuations.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Santa Clara, State of California, that the 2021 Advisory Redistricting Commission ("Commission") is hereby established and terminating upon completion of its work in advising the Board of Supervisors regarding the 2021 supervisorial redistricting process.

BE IT FURTHER RESOLVED that the Commission is tasked with conducting public hearings to receive public input regarding the drawing of supervisorial district boundaries in compliance with state and federal law and providing recommendations to the Board of Supervisors regarding the placement of the supervisorial district boundaries.

Resolution Establishing 2021 Advisory Redistricting Commission

Page 1 of 4

BE IT FURTHER RESOLVED that the Commission shall be composed of fifteen (15) qualified members, three from each current supervisorial district, appointed as follows:

- 1. Five members, one from each supervisorial district, shall be selected at random from a select pool of qualified applications. Applications will be made available by April 26, 2021 and shall be due by May 28, 2021. The pool would consist of one nominee from each supervisorial district selected by the County Counsel, the County Executive, and the Clerk of the Board. Each one of those three officers shall select independently, in that order, and so three nominees shall be in the pool for each supervisorial district for subsequent random selection. The random selection shall be held in public (virtually) by the Office of the Clerk of the Board on June 9, 2021. The randomly selected members shall subsequently be appointed by the Board of Supervisors. Those not selected will be returned to the remaining pool of qualified applications for each respective district.
- 2. Five members shall be nominated—one by each supervisor—from the remaining pool of qualified applications from their respective district. Each Supervisor shall nominate, and the Board shall then appoint, a member with the goal of diversifying the Commission, with diversity defined across a broad range of demographics, political party, and other social factors and ensuring representation of their respective district. Those not selected will be returned to the remaining pool of qualified applications for each respective district.
- 3. In July 2021, five members shall be directly appointed by the ten Commissioners appointed during the first two steps of the process, with one Commissioner selected from a pool of applicants residing in each supervisorial district. These members shall also be appointed with the goal of diversifying the commission, with diversity defined across a broad range of demographics, political party, and other social factors.

BE IT FURTHER RESOLVED that if the first 10 commissioners are unable to appoint the final five members by July 30, 2021, the unfilled seats shall be filled by appointment by the Board of Supervisors. Each Supervisor would be responsible for nominating a resident of their respective districts for the unfilled seats for consideration for appointment by the Board as a whole.

BE IT FURTHER RESOLVED that applicants to the Commission must meet the following qualifications, and members who are appointed to the Commission must continue to meet the qualifications throughout their service on the Commission. Administration, in consultation with the Office of the County Counsel, will review applications to verify applicants meet the qualifications, providing notice and opportunity to provide additional information to applicants deemed not to be qualified. Failure to meet the qualifications will disqualify an applicant. And failure to subsequently meet the qualifications will cause a member of the Commission to be removed from their seat. If a seat becomes vacant for any reason, the vacancy will be filled in the same manner as the original nomination and appointment. The qualifications for the Commission are that applicants and members:

1. Must be a registered voter in Santa Clara County.

- 2. Must not be an elected official of the County, or a family member, staff member, or paid campaign staff of an elected official of the County.
- 3. Must have the ability to serve from June through December 2021 and attend all meetings of the Commission.
- 4. Must possess experience that demonstrates the ability to comprehend and apply the applicable State and Federal legal requirements.
- 5. Must possess experience that demonstrates analytical skills relevant to the redistricting process and voting rights.
- 6. Must have the ability to complete training regarding local government ethics, statement of economic interests, analytical skills, voting rights, county profile with demographic information, and mapping software.
- 7. May not be a candidate for an elective office of the County or serve as an appointed officer of the County (including service on another board or commission).
- 8. May not endorse, work for, volunteer for, or make a campaign contribution to, a candidate for an elective office of the County.
- 9. May not serve as an officer of, employee of or paid consultant to:
 - o a campaign committee or a candidate for elective office of the County.
 - o a political party or as an elected or appointed member of a political party central committee.
 - o a currently serving elected officer of the County.

BE IT FURTHER RESOLVED that the Commission will conduct its meetings in accordance with Elections Code sections 21507, 21507.1, and 21508; and the Ralph M. Brown Act.

BE IT FURTHER RESOLVED that the Commission shall be governed by the following additional rules:

- 1. The Commission shall select a chair and vice chair who will coordinate with County staff regarding meeting agendas. The chair shall preside over meetings, with the vice chair doing so in the absence of the chair.
- 2. Quorum shall be eight members of the Commission. A quorum is required for the Commission to initiate the transaction of business at any meeting of the Commission. A motion passes only when a majority (8) of the membership seats (not just those members present or those seats that are filled) votes in support of the motion.
- 3. No Commissioner shall be permitted to vote upon an item unless present (in-person or by teleconference if properly noticed and implemented). Voting by proxy shall not be permitted.

BE IT FURTHER RESOLVED that the Commission members are prohibited from communicating about redistricting matters outside of a public meeting. This prohibition does not prohibit communication between commissioners, county staff, and consultants that pertain to meeting procedures such as scheduling meetings, preparing the agenda, or questions about the Brown Act, or any communications from or to the Office of the County Counsel. Should input from non-commissioners be submitted to a commissioner outside of a public meeting, commissioners will follow the process established by the County for collecting input, properly posting on the County's website, and notice communications during public meetings.

BE IT FURTHER RESOLVED that the staff from the Office of the County Executive shall provide staff assistance and staff from the Office of the County Counsel shall provide legal assistance, as necessary, for the work of the Commission.

BE IT FURTHER RESOLVED that the Commission shall automatically be terminated with no further Board action required upon adoption by the Board of new supervisorial district boundaries.
