RECOMMENDED ACTION

Receive report from the Office of the County Executive relating to the 2021 Redistricting Process.

REASONS FOR RECOMMENDATION

Outreach and community engagement are important throughout the redistricting process to inform the community about public workshops and hearings where community members can submit their input on redistricting recommendations and submit proposed maps.

Meetings of the 2021 Advisory Redistricting Commission (Commission) are public meetings and are planned to be conducted virtually through September and in-person starting in October. It is important to note that the date, time, and location for any Commission meeting must be noticed on the internet at least five days prior. Minutes and video from meetings will be posted to the agenda website within two weeks after the public hearing or workshop so the public can review the input provided to the Commission.

Administration will continue to monitor public health orders and guidelines associated with the pandemic to determine the best method for ensuring public access to participate in meetings. One potential recommendation Administration is exploring to ensure participation, is working with outreach partners to identify community locations that can host members of the public to leverage existing technology to participate in virtual Commission meetings, submit community of interest information, and/or submit draft maps for consideration. This will allow participation of members of the public who may not otherwise have access to appropriate technology or who may feel more welcome and able to participate in a familiar space.

To ensure redistricting work is completed in public, Commissioners are prohibited from communicating about redistricting matters outside of a public meeting. Should input

from non-commissioners be submitted outside of a public meeting, the Administration will post communications to the redistricting website and notice communications during public Commission meetings. Administration is also available to meet with community groups to explain the process and encourage participation.

To comply with redistricting requirements and encourage community participation, the County will provide language assistance and disability accommodations upon request for all public workshops and meetings, with the process and languages outlined below. Administration has established a redistricting website at www.sccgov.org/2021redistricting. The website will have content in English, Spanish, Vietnamese, Chinese, and Tagalog and will remain on the County's homepage for ten years. The redistricting website will also include, but is not limited to: an overview of the 2021 redistricting process, draft maps, County information (population, voter information, racial, and ethnic information), mechanisms for accepting public submissions of testimony or draft maps, and meeting notices, materials, and minutes. Since this is the main source of information on redistricting, the website will continue to evolve, and the Commission and members of the public may submit content suggestions to 2021redistricting@ceo.sccgov.org.

Commission Meeting Translation Services

The County is required to ensure non-English speaking communities may participate in the redistricting process. Language interpretation services must be available in Spanish, Vietnamese, Chinese, and Tagalog upon request, but when possible, Administration will leverage existing resources to provide interpretation services in other languages. If language interpretation services are needed for a Commission meeting, they can be requested through the Office of the Clerk of the Board at (408) 299-5001, no less than three business days prior to the meeting to request an interpreter. This information is also included on each Commission meeting agenda in Spanish, Vietnamese, Chinese, and Tagalog.

Community Engagement Process

The condensed timeline requires an expedited, wide-reaching outreach strategy. Clear and concise messaging is needed to increase awareness regarding the redistricting process. The Administration will closely coordinate with outreach partners to ensure thorough outreach and leverage the robust community contacts engaged in the Census 2020 process, the 2020 elections outreach process, and pandemic outreach and response efforts. Community outreach partners will be identified to reflect our diverse county. A draft list for Commission consideration is attached to this report for discussion and Commission input. Throughout the community engagement process, the redistricting team is available to attend community meetings to present the County's 2021 redistricting process and demonstrate how the community can get involved. Given the compressed timeline, Administration recommends three outreach phases, which are described in greater detail below:

Outreach Phase	Timeframe
1. Public Awareness	August 2021
2. Community of Interest	August – September 2021
3. Mapping	October 2021

1. Public Awareness

The Administration recommends a public awareness campaign in August regarding the 2021 redistricting process. The campaign would include launching the Redistricting Toolkit and Commissioner informational videos or social media posts, which can be created by the County's Office of Communications and Public Affairs. Commissioner content would be optional, but include the following information:

- Why Commissioners want to be on the Commission
- Why redistricting is important
- Why the community should participate

Administration will also seek to complete an informational video or social media post in English, Spanish, Vietnamese, Chinese, and Tagalog.

2. Community of Interest

In August and September, Administration recommends focusing on the Community of Interest process. A community of interest (COI) is a neighborhood, community, or group of people who are likely to have common policy concerns and who might therefore benefit from being in a single district. The California Elections Code defines community of interest as "a population that shares common social or economic interests that should be included within a single supervisorial district for purposes of its effective and fair representation. Communities of interest do not include relationships with political parties, incumbents, or political candidates." Cal. Elec. Code § 21500(c)(2). Communities of interest (COIs) are self-defined

and create a common story. They can be described by creating maps and narrative profiles and providing community stories.

Consideration of COIs is essential to successful redistricting, particularly since counties are required to prioritize communities of interest and local neighborhoods in drawing district boundaries above other criteria such as cities and census designated places. Redistricting should build up electoral boundaries from the underlying communities – using the process to empower groups that have similar backgrounds, experiences, and viewpoints in order to allow them to unify and elect candidates of their choice. Developing communities of interest for a redistricting process is the most important part of public outreach. Listening to residents allows for the development of knowledge about what communities exist, and how they interact with the County.

A draft Community of Interest (COI) Form is attached to this report to facilitate the gathering of narrative profiles for the Commission. Redistricting Partners will also present an overview of the mapping software, DistrictR so the community can also create and submit maps outlining their community of interest. In addition to completing a Community of Interest Form, or creating a map, the community can provide public comment directly to the Commission at any meeting. Public comment should also address the questions established on the COI form:

- 1. What binds your community together or creates its shared identify? Are there common interests or issues in your community? Describe how they are important.
- 2. Explain the geographical location of your community of interest. What are the physical boundaries? Are there nearby areas you want to be with? Include any key landmarks such as parks, county facilities, schools, church, or other boundaries.
- 3. What is the rationale for your community of interest to be used in the Board of Supervisor redistricting process? Please describe how the issues before the Board of Supervisors have an impact on your community.
- 4. What else would you like to tell us about your community? How would keeping your community intact enhance the quality of its representation?

c. Attend a Commission meeting and read your comments to the 2021 Advisory Redistricting Commission.

Administration also recommends the Commission agendize community presentations where groups can be scheduled to present to the Commission for 3 to 5 minutes on their community of interest. Community groups can sign up to make a presentation by emailing 2021redistricting@ceo.sccgov.org to be scheduled by staff in coordination with the Chair. Community presentations will serve as the initial phase to review COI testimony to develop the basis upon which eventual districts will be constructed.

3. Mapping

In October, once census data is available the mapping process can begin. Outreach at this point will focus on how the public can submit draft plans and feedback on any plans created by the staff, consultants, or the Advisory Redistricting Commission. COI testimony should continue, as it will help inform changes to the plans and provide ways for the new districting plan to be justified by these elements rather than disallowed criteria.

Redistricting Toolkit

Administration has prepared draft documents for discussion by the Commission. Once finalized, these documents will be packaged as a Redistricting Toolkit with fillable forms and translated into English, Spanish, Vietnamese, Chinese, and Tagalog. The Redistricting Toolkit will be posted on the redistricting website and distributed to outreach partners. The proposed Redistricting Toolkit will contain:

- Commission Meeting Schedule
- 2021 Advisory Redistricting Commission Workplan
- Redistricting Information Sheet
- Community of Interest Form
- Outreach Partners

Media Outreach

The proposed approach to media for the 2021 Advisory Redistricting Commission will involve a mix of traditional and non-traditional media. The Redistricting Toolkit will be provided to media organizations, with an emphasis on non-English speaking media utilizing television and radio to minority communities.

The County's Office of Communications and Public Affairs will continue to prepare media releases announcing important milestones in the process. Information will also be posted regular through the County's official social media channels such as Facebook, nextdoor, and Twitter. BACKGROUND

At the April 6, 2021 (Item. No 22) Board of Supervisors meeting, the framework was established for the 2021 Redistricting Process. The framework aims to maintain flexibility to maximize opportunities for community engagement during a compressed timeline because of the significant delay in the release of the 2020 census data. This framework also included establishing a fifteen-member 2021 Advisory Redistricting Commission, with three commissioners from each supervisorial district.

The Board of Supervisors adopted Resolution BOS-2021-50 establishing the 2021 Advisory Redistricting Commission on April 20, 2021 (Item No. 59). The resolution directed Administration to establish an advisory redistricting commission composed of 15 members to hold public hearings, collect community input, and recommend to the Board updated supervisorial district boundaries. The resolution sets forth the criteria for membership on the Commission as well as the selection and appointment process for the members.

Statutory Guidelines

In addition to the County's process, the California Elections Code establishes statutory guidelines for the reapportionment of supervisorial districts in Division 21, Chapter 6. Supervisorial Districts. Those provisions include detailed requirements for outreach and encouraging public participation in the redistricting process:

- **§21508¹.** (a) The board shall take steps to encourage residents, including those in underrepresented communities and non-English speaking communities, to participate in the redistricting public review process. These steps shall include a good faith effort to do all of the following:
 - (1) Providing information to media organizations that provide county news coverage, including media organizations that serve language minority communities.
 - (2) Providing information through good government, civil rights, civic engagement, and community groups or organizations that are active in the county, including those active in language minority communities, and those that have requested to be notified concerning county redistricting.
- (b) The board shall arrange for the live translation in an applicable language of a public hearing or workshop held pursuant to this chapter if a request for translation is made at least 72 hours before the hearing or workshop, unless less than five days' notice are provided for the hearing or workshop, in which case the request shall be made at least 48 hours before the hearing or workshop.
- (c) Notwithstanding Section 54954.2 of the Government Code, the board shall publish the date, time, and location for any public hearing or workshop on the internet at least five days before the hearing or workshop. However, if there are fewer than 28 days until the deadline

to adopt boundaries, the board may publish the agenda on the internet for at least three days before the hearing or workshop.

- (d) (1) A draft map shall be published on the internet for at least seven days before being adopted as a final map by the board provided that, if there are fewer than 28 days until the deadline to adopt boundaries, the draft map may instead be published on the internet for at least three days.
 - (2) Each draft map prepared by a member of the board or by employees or contractors of the county shall be accompanied by information on the total population, citizen voting age population, and racial and ethnic characteristics of the citizen voting age population of each proposed supervisorial district, to the extent the county has that data.
 - (3) (A) The board and employees or contractors of the county shall not release draft maps of supervisorial districts earlier than three weeks after the block-level redistricting database required by subdivision (b) of Section 8253 of the Government Code is first made publicly available. This subparagraph does not prohibit the board from holding public hearings or workshops on the placement of supervisorial district boundaries before the earliest date that draft maps of supervisorial districts may be released.
 - (B) If the period of time between the date that the redistricting database is made publicly available and the map adoption deadline is fewer than 90 days and more than 59 days, then the waiting period required by subparagraph (A) is reduced to one week. If the period of time between the date that the redistricting database is made publicly available and the map adoption deadline is fewer than 60 days, then the waiting period required by subparagraph (A) is waived.
 - (e) The board shall allow the public to submit testimony or draft maps in writing and electronically.
 - (f) The county shall either record or prepare a written summary of each public comment and board deliberation made at every public hearing or workshop held pursuant to this article. The county shall make the recording or written summary available to the public within two weeks after the public hearing or workshop.
 - (g) The board shall establish, and maintain for at least 10 years after the adoption of new supervisorial district boundaries, an internet web page dedicated to redistricting. The web page may be hosted on the county's existing internet website or another internet website maintained by the county. The web page shall include, or link to, all of the following information:
 - (1) A general explanation of the redistricting process for the county, in English and applicable languages.
 - (2) The procedures for a member of the public to testify during a public hearing or to submit written testimony directly to the board, in English and applicable languages.

- (3) A calendar of all public hearing and workshop dates. A calendar listing that includes the time and location of the public hearing or workshop satisfies the notice required by subdivision (c).
- (4) The notice and agenda for each public hearing and workshop.
- (5) The recording or written summary of each public hearing and workshop.
- (6) Each draft map considered by the board at a public hearing.
- (7) The adopted final map of supervisorial district boundaries.
- (h) For purposes of this section, "applicable language" means any language in which ballots are required to be provided in the county pursuant to Section 203 of the federal Voting Rights Act of 1965 (52 U.S.C. Sec. 10503).
- (i) This section does not apply when a county transitions from at-large to district-based elections.
- (j) Before January 1, 2021, and before January in each year ending in the number one thereafter, the Secretary of State shall publish on the internet a template explaining the county redistricting process that meets the requirements of paragraphs (1) and (2), inclusive, of subdivision (g). The Secretary of State shall publish the template in all of the languages into which ballots are required to be translated in the state pursuant to Section 203 of the federal Voting Rights Act of 1965 (52 U.S.C. Sec. 10503). The template shall be published in a conspicuous location on the Secretary of State's internet website.

(Amended by Stats. 2020, Ch. 90, Sec. 6. (AB 1276) Effective January 1, 2021.)

County of Santa Clara Redistricting Process

Every ten years, local governments use new census data to redraw their district lines to reflect how local populations have changed. <u>Assembly Bill 849 (2019)</u> requires cities and counties to engage communities in the redistricting process by holding public hearings and/or workshops and doing public outreach, including to non-English-speaking communities.

What is redistricting?

Every ten years, districts must be redrawn so that each district is substantially equal in population. This process, called redistricting, is important in ensuring that each board member represents about the same number of constituents. In Santa Clara County, the Board of Supervisors is responsible for drawing supervisorial districts. Redistricting is done using U.S. Census data, which is released around March 31, 2021. For the County of Santa Clara, the redistricting process must be completed by December 15, 2021.

Why does redistricting matter to me?

Redistricting determines which neighborhoods and communities are grouped together into a district for purposes of electing a board member.

The Board of Supervisors will seek input in selecting the next district map for our supervisorial districts. You have an opportunity to share with the Board of Supervisors how you think district boundaries should be drawn to best represent your community.

What do the existing supervisorial districts look like?

What criteria will our Board of Supervisors use when drawing district lines?

To the extent practicable, district lines will be adopted using the following criteria: (1) geographically contiguous districts (each supervisorial district should share a common border with the next), (2) the geographic integrity of local neighborhoods or communities shall be respected in a manner that minimizes its division, (3) geographic integrity of a city shall be respected in a manner that minimizes its division, (4) easily identifiable boundaries that follow natural or artificial barriers (rivers, streets, highways, rail lines, etc.), and (5) lines shall be drawn to encourage geographic compactness. In addition, boundaries shall not be drawn for purposes of favoring or discriminating against a political party.

How will our Board of Supervisors notify the public about redistricting?

The Board of Supervisors will reach out to local media to publicize the redistricting process. Also, we will make a good faith effort to notify community groups of various kinds about the redistricting process. Commission meetings are public and will be provided in applicable languages if residents submit a request in advance. The Board of Supervisors will notify the public about redistricting commission meetings, post maps online before adoption, and create a dedicated web page for redistricting information.

How can I get involved?

RECOMMENDED ACTION

Receive report from the Office of the County Executive and Redistricting Partners relating to mapping software.

REASONS FOR RECOMMENDATION

The 2021 Redistricting Process will utilize an online mapping tool. This tool will allow for public participation in the process by making it possible for the public to draw where their community is geographically and to generate proposed redistricting plans for the supervisorial districts through their web-browsers. Online submissions will be agendized, distributed, and posted to the Commission's agenda as quickly as possible.

The County will be utilizing the online mapping tool DistrictR for the 2021 redistricting process. DistrictR operates in-browser and does not require login or downloads and works on tablets as well as computers, which provides for maximum accessibility. It is an open source program, with permissive licenses and does not collect information about users.

Redistricting Partners, the County's consultant for the 2021 Redistricting Process, will provide training on DistrictR to the 2021 Advisory Redistricting Commission during its public commission meetings, which are open to the community.

The initial overview training will be presented as part of this report and will formally kick-off the community of interest process, during which the community will be asked to draw their Communities of Interest on DisitrictR and complete Communities of Interest forms. This process will occur from August through September. Maps and forms can be submitted electronically online or:

It will provide the community the opportunity to draw proposed supervisorial district boundaries that complement communities of interest. The mapping phase is expected to occur in October.

RECOMMENDED ACTION

Receive report from Redistricting Partners relating to redistricting principles.

REASONS FOR RECOMMENDATION

The County has contracted with Redistricting Partners to serve as expert consultants to assist with the 2021 Redistricting Process. They will be hosting a series of trainings to assist the Commissioners and the community to understand the redistricting process. For the training on redistricting principles, Kathay Feng, the National Redistricting Director for Common Cause will present to the 2021 Advisory Redistricting Commission.

Ms. Feng has led Common Cause's work to challenge partisan and incumbent gerrymandering, through litigation, state-based organizing around ballot initiatives and legislation, and creating new platforms for community-based redistricting. As Executive Director of California Common Cause, she championed and won election and redistricting reforms, stronger government sunshine and accountability laws, campaign finance reforms, stronger net neutrality laws, and the voting rights of traditionally disenfranchised communities.

Ms. Feng is the architect of California's Citizens Redistricting Commission, leading the multi-year effort to study, write, and pass the two initiatives, Propositions 11 and 20, which created the commission and new community-focused process. She also led efforts that secured passage of California laws bringing online voter registration and same day registration to the state.

Before joining Common Cause in 2005, she headed the Voting Rights and Anti-Discrimination Unit at the Asian Pacific American Legal Center. She serves, or has served, on numerous boards including the California Secretary of State's Advisory Committee on Voter Participation and Outreach, the Los Angeles County Human Relations Commission, and the Asian Pacific Policy and Planning Council. She is a graduate of Cornell University, and holds a law degree from UCLA School of Law.



SUBJECT: Role of the Commissioner

RECOMMENDED ACTION

Receive report from Redistricting Partners relating to the role of the Commissioner in the redistricting process.

REASONS FOR RECOMMENDATION

The County has contracted with Redistricting Partners to serve as expert consultants to assist with the 2021 Redistricting Process. They will be hosting a series of trainings to assist the Commissioners and the community to understand the redistricting process. For the training on the role of the Commissioner - Cynthia Dai, Connie Mallory, and Carlos Marquez - who each served as redistricting commissioners in other efforts ten years ago, will present to the 2021 Advisory Redistricting Commission.

Ms. Dai and Ms. Mallory were members of the inaugural California Citizens Redistricting Commission. Mr. Marquez was a member of the independent San Diego Redistricting Commission for the City of San Diego. Biographies on each are attached.

BACKGROUND

Every 10 years, following the release of data from the decennial Census, jurisdictions that elect members of their legislative body by districts must revise district boundary lines to ensure the districts are consistent with federal, state, and local legal requirements.

In April 2021, the Board of Supervisors established a framework for the 2021 Redistricting Process, which included the establishment of a fifteen-member 2021 Advisory Redistricting Commission. The framework also included the use of a consultant to help facilitate community engagement and participation in the Redistricting Process.

The County's consultant is Redistricting Partners. The firm has worked at the statewide and local level, with the tools to help local governments complete the process and make redistricting bring people closer to their government.

Cynthia Dai is founder and CEO of Dainamic Consulting, Inc., a San Francisco-based strategy and interim executive firm that accelerates growth. Her diverse clientele includes social enterprise and public sector organizations such as Benetech, Digital Divide Data, Frameline, Sutardja Center for Entrepreneurship and Technology, UnidosUS (formerly National Council of La Raza), and the Skoll Foundation; global companies like Canon, Cisco, Intel, Microsoft, Motorola, Philips Electronics, and Toyota; as well as Silicon Valley startups such as Gigster, Pacific Data Images (now PDI DreamWorks), Persistence (acquired by Progress Software), and Salon.com.

Cynthia was one of 14 selected to serve on California's inaugural 2010 Citizens Redistricting Commission (CRC), widely considered the gold standard in independent redistricting. The CRC eliminated partisan gerrymandering in under eight months with fair electoral maps, upheld by the California Supreme Court in multiple unanimous decisions, and approved by voters with a 2-to-1 margin. This work was recognized by an Innovation for Public Engagement in Government grant from Harvard Kennedy's Ash Center. In addition to participating on the CRC's rotating leadership, Cynthia chaired the effort to deploy multi-partisan Commissioner teams to share Redistricting Partner's model via 30+ visits to support reform advocates in a dozen states.

Last summer, Cynthia was a 2020 Census Enumerator. She is active in the Open Primaries movement and speaks on ranked-choice voting. Also an educator and mentor, Cynthia launched an entrepreneurship program in China and works with accelerators like the European Innovation Academy and Global Social Benefit Institute. She previously served on the boards of the Miller Center for Social Entrepreneurship, Lyon-Martin Women's Health Services, and Habitat for Humanity San Francisco. Cynthia earned an MBA from the Stanford Graduate School of Business and a B.S. in Electrical Engineering and Computer Science with honors from University of California Berkeley.



Connie Malloy serves as Chief Executive Officer of the Panta Rhea Foundation, catalyzing a just and sustainable world. She also serves as a strategic advisor to individual donors, families, foundations, and philanthropic collaboratives.

Connie served as a Commissioner and Chair of California's inaugural Citizens Redistricting Commission from 2010-2020, and now consults and trains on independent redistricting. She is a Board Director for the national Funders Committee for Civic Participation, and for Southern California Grantmakers.

Connie previously served as Portfolio Director at The James Irvine Foundation. During her seven-year tenure she deployed over \$200 million in grants to support economic and workforce development, expand voting access, social impact bonds, and the foundation's annual Leadership Awards. Prior to her funder roles, Connie oversaw programs at Urban Habitat where she launched the Boards and Commissions Leadership Institute. The institute trains leaders committed to advancing social justice for service on local and regional boards and commissions and provides individualized support throughout their leadership roles.

Earlier in her career, Connie served as a U.S. Department of Housing and Urban Development Fellow and Peace Corps Volunteer in Bolivia. Connie earned her master's degree in urban planning from the University of California, Berkeley, and a bachelor's degree from La Sierra University in Riverside, California.



Carlos Marquez is the owner of CM3 Advocacy LLC, a Sacramento-based government affairs firm that represents public education and healthcare clients. He joined the team at Redistricting Partners in 2020 with over a decade of local government and statewide policymaking experience. Most recently, Carlos served on the executive committee of Proposition 13, a statewide public school bond campaign.

Prior to founding CM3 Advocacy in 2019, Carlos served as Senior Vice President, Government Affairs at the California Charter Schools Association (CCSA) where he managed the organization's legislative, budget, and regulatory priorities and interfaced with a host of school districts, county offices of education, city councils, the state legislature, and several state agencies.

In 2011, Carlos steered the citizen-led San Diego Redistricting Commission, as Vice-Chair, in adopting a map that was lauded fair, on-time and under-budget. Additionally, under Carlos' leadership, the San Diego Redistricting Commission produced a map that preserved high-ranking communities of interest and established two new empowerment districts.

Since then, Carlos has helped advance the missions of national advocacy organizations that include the American Civil Liberties Union, United Way Worldwide, Service Employees International Union, and the LGBTQ Victory Fund.




