### **REASONS FOR RECOMMENDATION**

The 2021 Advisory Redistricting Commission completed its targeted outreach schedule for the five supervisorial districts and heard from the commissioners representing the districts at its October 13, 2021, meeting.

The Commission will receive public testimony and group presentations. Testimony shared with the commission should cover the following questions that are outlined on the Community of Interest form:

- Does your community have a shared culture, interests, activity, business, or bond?
- Does your community live in a concentrated area?
  - Can you draw your community on a map?

- Is there density within your community (many people in your community living closely together)?

The final component of the Communities of Interest item will be a discussion between the Commission, staff, and Redistricting Partners about the communities of interest testimony received at the meeting and submitted through the County's redistricting website (<a href="https://www.sccgov.org/2021redistricting/COI">www.sccgov.org/2021redistricting/COI</a>) and potential impacts on draft maps.

Members of the public, groups or organizations, and Commissioners are invited to submit their own Community of Interest form or draw their community on the County's redistricting website to be discussed by the Commission.

The information below provides additional information on the components of the meeting.

## Public Testimony

Members of the public will be provided the opportunity to share information on their community of interest for up to two minutes each. This information will be shared as public comment and the Commission will have an opportunity to discuss at the end of the item. If members of the public wish to also submit their testimony in writing, or provide additional information, they can email the redistricting team (2021redistricting@ceo.sccgov.org) to have their testimony added to the County's redistricting website (www.sccgov.org/2021redistricting/COI).

## Communities of Interest Representatives

Groups or organizations who sign up in advance by emailing the redistricting team (2021redistricting@ceo.sccgov.org) will each have up to five minutes to make a presentation. After each presentation, the Commission will have the opportunity to ask questions of the presenters. Staff will work with groups to have presentations added to the agenda as quickly as possible. Currently, Project Sentinel and the Unity Mapping Table, which is comprised of representatives from the Asian Law Alliance, South Bay AFL-CIO Labor Council, and Silicon Valley Rising Action have requested to present on October 20, 2021.

## **RECOMMENDED ACTION**

Receive report from the Office of the County Executive, Office of the County Counsel, and Redistricting Partners relating to draft Supervisorial District maps, and discuss and approve recommendations regarding mapping, if any.

## **REASONS FOR RECOMMENDATION**

The County of Santa Clara has contracted with expert consultants, Redistricting Partners, to assist with the 2021 redistricting process and to prepare draft maps based on Communities of Interest testimony submitted to the 2021 Advisory Redistricting Commission.

At the October 13, 2021 Advisory Redistricting Commission (Commission) meeting (Item No. 5), the redistricting team provided information on the current districts with 2020 census data and the Commission reviewed the first three draft plans submitted by Redistricting Partners: Plans X, Y, and Z. The first three draft plans included two versions based on Communities of Interest testimony and one based on the existing supervisorial district lines. Based on community testimony received and discussion amongst the Commissioners, new draft maps will be submitted as supplemental information to this report for review at the October 20, 2021 meeting.

Communities of Interest testimony is an important building block which allow the County to know which areas of our County share values and would benefit from being aligned for representation on the Board of Supervisors. To review Communities of Interest submissions, please visit <u>www.sccgov.org/2021redistricting/COI</u>. Submissions as of October 13, 2021 are also attached to this report with hyperlinks to individual submissions and published to the redistricting website daily.

The Commission is publicly reviewing draft maps and encourage the community to attend Commission meetings to provide feedback. If you would like to create your own maps for consideration or review maps submitted to the County, please visit the mapping software page at <u>https://districtr.org/event/Santa\_Clara\_County</u>.

## Draft Map Review Process

On October 13, 2021 the Commission reviewed the first draft maps developed by Redistricting Partners and they remain posted on the redistricting website. Commissioners may consider maps produced by Redistricting Partners and maps submitted by the public. Maps will be iterative, and it will be helpful feedback to hear if there are communities or neighborhoods that are split and should remain together.

As Redistricting Partners creates updated drafts, they will draft maps that meet the legal criteria and the Board's direction for each district to be equal in size to the greatest extent possible. The Commission's virtual meetings on Wednesday, October 20, 2021 at 6:30 pm and Saturday, October 23, 2021 at 2:00 pm will provide an opportunity for continued discussion and community feedback, with the recommendation finalized on October 27, 2021 at 6:30 pm for presentation to the Board on November 2, 2021 at 6 pm.
